## **ORDER**

The State Police Chief as per letter read as 2 <sup>nd</sup> paper above has informed that 285 police personnel have been awarded with Chief Minister's Police Medal for the year 2025 as per Government order read as 1<sup>st</sup> paper above. A specification committee has been constituted in PHQ for checking the Malayalam inscriptions in the specification available with the Department. As per the report of the Specification committee, certain changes has been made in Malayalam inscriptions embedded in the Chief Minister's Police Medal and quotation has been invited for the purchase of Police Medal.

2) The distribution of the Chief Minister's Police Medal was scheduled on 01.11.2025. As the medals have to be purchased within that date, and considering the urgency of the situation, supply order was placed with L1 firm M/s Sainik Bhandar, New Delhi for the purchase of 290 Nos (285 for distribution and 5 extra to meet any contingency) of Chief Minister's Police Medal. The firm, M/s Sainik Bhandar, New Delhi supplied all the items and after verification, the committee recommended to accept 287 Nos. of Police

Medal. As such, the Police Medals were distributed on 01.11.2025 and an amount of Rs.2,63,814/- has been released to the firm towards the cost of 287 Nos. of Chief Minister's Police Medal. The State Police Chief has therefore requested to ratify the action on the procurement of Chief Minister's Police Medal through quotation without inviting tenders for an amount of Rs.2,63,814/-.

- 3) Government have examined the matter in detail and are pleased to ratify the action taken by the State Police Chief in procuring Chief Minister's Police Medal for an amount of Rs.2,63,814/- (Rupees Two Lakh Sixty Three Thousand Eight Hundred and Fourteen only) through quotation without inviting tenders, in view of the urgency of the situation that the medals had to be purchased and inspected within a period of only 20 days.
- 4) The State Police Chief shall ensure that such instances are not repeated in future and that all procedural formalities are followed without exception.
