## **ORDER**

As per G.O read as 1<sup>st</sup> paper above, Administrative Sanction was accorded for an amount of ₹1700 lakh allocated under the head of account 2235-02-190-97-34-OC(P) to Managing Director, Kerala State Welfare Corporation for Forward Communities Ltd for awarding scholarships to the students belonging to economically weaker sections among forward communities in Kerala for the year 2022-23 under Merit Scholarship Scheme. An amount of ₹8,45,41,700/- was released as 1st installment for meeting the expenditure under Merit Scholarship Scheme (2022-23). A total of 22516 beneficiaries were selected from the applications received. But beneficiaries with identical annual family income which was the bench mark criteria for selection, was seen excluded from awarding scholarship at that time due to unavailability of adequate fund. Hence, more fund was needed for awarding scholarship for the year 2022-23. For the Financial Year 2022-23, a total amount of ₹414 lakh [Resumed fund ie; allotted amount for the year 2021-22) was released vide paper read as 2nd above under the above head of account itself for meeting the expenditure for selected beneficiaries for the Financial Year 2021-22 from 2022-23 financial year's budget. Out of the released fund, an amount of ₹2.63 crore was spent to Bhavana Samunnathi scheme (2022-23). Hence balance amount was available under this head.

2. For ensuring maximum utilization of available funds, based on the resolution of the Director Board meeting read above, an amount of ₹60,01,474/- (Rupees Sixty Lakh One Thousand Four Hundred and Seventy Four Only) was re appropriated from Bhavana Samunnathi Scheme to Merit Scholarship Scheme 2022-23 within the same head of account for disbursing scholarships to the selected children. As such MD,KSWCFC vide letter read above has requested the Government to ratify the action of re appropriating an

amount of ₹60,01,474/- (Rupees Sixty Lakh One thousand four hundred and seventy four Only) earmarked for the Bhavana Samunnathi Scheme for disbursing to the remaining beneficiaries selected under Merit Scholarship Scheme 2022-23.

**3.** Government have examined the matter in detail and are pleased to ratify the action of the Managing Director Kerala State Welfare Corporation for Forward Communities Ltd in having re appropriated an amount of ₹60,01,474/- (Rupees Sixty Lakh One thousand four hundred and seventy four Only) earmarked for the Bhavana Samunnathi Scheme, for disbursing the same to the remaining beneficiaries selected under Merit Scholarship Scheme 2022-23 by the Corporation under the same head of account 2235-02-190-97-34-OC (P) on condition that such activity in the future shall be dealt with severely without exception.
