ORDER

As per the Govt. Order read above, Administration Sanction was accorded for an amount of Rs.461.33 lakh (RIDF Share Rs.438.29 + State Share Rs.23.07) for the project "Establishment of Value Added Fish Processing Centre in Mulakkuzha Panchayat, Chengannur", under NABARD Tranche XXVIII.

2. The Director of Fisheries, as per the letter read above, has furnished the drawal application under Rural Infrastructure Development Fund -Tranche XXVIII, in the prescribed proforma towards the reimbursement claim of the project "Establishment of Value Added Fish Processing Centre in Mulakkuzha Panchayat, Chengannur" implemented by Matsyafed. An expenditure of Rs.86.26404 lakh (Rupees Eighty Six lakh Twenty Six thousand Four Hundred and Four only) has been incurred for the period October 2025 and the Director of Fisheries has requested to accord sanction for the same.

3. Government examined the matter in detail and are pleased to accord sanction to release an amount of Rs. 81.95009 lakh (Rupees Eighty One lakh Ninety Five Thousand and Nine only) under the H/A 4405-00- 104-53 (PV) to Matsyafed

towards the eligible RIDF share corresponding to the present claim, subject to the condition that the Director of Fisheries should ensure that the purchased items reported in the RC were included in the original approved DPR and purchase was carried out strictly in accordance with the existing guidelines. If any deviation is found, only eligible amount need be released to Matsyafed. The release details are as follows:
