ORDER

As per Government Order read as 1st paper above, sanction has been accorded for starting One Health Programme in 4 Pamba basis district Pathanamthitta, Alappuzha, Kottayam and Idukki and guidelines has been issued for its effective implementation.

2) As per Government orders read as 2nd and 3rd paper above, sanction was accorded for an amount of Rs. 49.02 Crores under the Rebuild Kerala Initiative in connection with DLI-6 of the Resilient Kerala Programme for Results (PforR) One Health Programme. Out of which Rs. 14.74 Crore is earmarked for Laboratory System for

combating zoonotic disease out break.

3) As per Government Order read as 5th paper above, 10 Crore sanctioned as first installment for activities under One Health Programme. State Level Core Committee meeting of One Health Programme held on 08/11/2023 has decided to use Rs. 1 Crore for lab strengthening activities.

4) As per letter read as 8th paper above, the Director of Health Services has submitted a proposal for an amount of Rs. 1,18,69,086/- (Inclusive of all taxes, surcharges and Cess) for purchasing equipments and other articles for Laboratory Strengthening with proforma invoice of the Kerala Medical Services Corporation Limited read as 7th paper above and the State Level Core Committee meeting of One Health Programme held on 31/01/2024 has approved the same .

5) Government have examined the matter in detail and are pleased to sanction an amount of Rs. 1,18,69,086/- (Rupees One Crore Eighteen Lakh Sixty Nine Thousand and Eighty Six Only) (Inclusive of all taxes, surcharges and Cess) for purchase of equipments and other articles for Laboratory Strengthening with proforma invoice of the Kerala Medical Services Corporation Limited read as 7th paper above as per the minutes of the State Level Core Committee meeting of One Health Programme held on 31/01/2024 subject to strict compliance of Stores Purchase Rules.
