ORDER

The Health Sector Grants under 15th Finance Commission amounting to ₹ **616.2253** crore (HSG Release Nos.112/2025-26, 113/2025-26, 114/2025-26, 115/2025-26, 116/2025-26, 117/2025-26 and 118/2025-26 dtd 27/11/2025) for the FY 2024-25 has been authorized to Director (Rural/Urban), LSGD vide Government Order read as 2nd paper above.

2) As per the release order of the health sector grant for FY 2024-25, 'the State Finance department shall transfer grants-in-aid directly to the State health Department or any other department authorized by the State Level Committee for procurement under this component within ten working days of receipt from the Union Government without any deduction and any delay beyond ten working days will require the State Government to release the same with interest as per the effective rate of average interest on market borrowings/State Development Loans (SDLs) for the previous year.' There was a delay of 43 days in transfer crediting the health sector grant to Director (Rural) LSGD and a delay of 44 days in transfer crediting the health sector grant to Director (Urban) LSGD.

3) In view of the administrative delay caused in transfer of funds, Government, are pleased to authorize an amount of Rs.5,25,38,516/- (Rupees Five crore Twenty Five lakh Thirty Eight thousand Five hundred and Sixteen only) to Director(Rural/Urban) LSGD as interest for the period of delay in transfer of Health Sector Grants under XVth Finance Commission Award for the FY 2024-25 as detailed below:
