ORDER

NCDC sanctioned Rs.3269.997 lakh to Government of Kerala for implementing (NCDC assisted Integrated Fisheries Development Project 2022-23) IFDP 2022-23 through Primary Fishermen Development & Welfare Co-operative Societies at a block cost of Rs.3633 lakh under Pradhan Mantri Matsya Sampada Yojana (PMMSY) Scheme, as per letter read as 1st paper above and as per Government Order read as 2nd paper above, Administrative Sanction was accorded for the Integrated Fisheries Development Project 2022-23 at a total project outlay of Rs.3633.33 lakh.

2. NCDC approved advance release of financial assistance of Rs.2083.33 lakh as term loan for implementation of Integrated Fisheries Development Project 2022-23, as per letter read as 3rd paper above and the Director of Fisheries requested to release Rs.2726.67 lakh to Matsyafed through budget provision and additional authorization, as per letter read as 4th paper above.

3. Government have examined the matter in detail and are pleased to release **Rs.1300 lakh (Rupees Thirteen Crore Only)** as the Loan, Subsidy and Share Capital components as shown in the table below towards NCDC-assisted Integrated Fisheries Development Project (IFDP) 2022-23 subject to the following terms and conditions.
