The Director has requested to revise the proposal which has been approved by the Government for an amount of Rs. 4,85,30,185/- vide reference cited 1st above.

(2) The State Level Working Group held on 22/12/2025 considered the revised proposal submitted by the Director,Scheduled Tribes Development Department and recommended approval of the revised proposal for Skill Training to ST Youth in Rural Employment (Gothra Jeevika) in the second phase for Rs.3,13,09,659/- (Rupees Three Crore Thirteen lakh Nine Thousand Six Hundred and Fifty Nine Only).
