ORDER

The Ministry of Social Justice and Empowerment, Government of India, as per the paper read as 1st paper above, has issued Mother Sanction releasing an amount of ₹6,27,08,300/- (Rupees Six Crore Twenty Seven Lakh Eight Thousand Three Hundred only) as Central Assistance to the State of Kerala for the Financial Year 2025–26 under SLS KL263 for the implementation of schemes under the Protection of Civil Rights Act, 1955 and the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 through SNA–SPARSH.

2. As per the Government order read as 2nd paper above, accorded sanction for the release of ₹12,00,00,000/- (Rupees Twelve Crore only), being the Central and State share, to the Director, Scheduled Castes Development Department for the implementation of schemes under the above Acts through SNA–SPARSH, subject to the condition that the amount shall be utilized strictly in accordance with the scheme guidelines and through the concerned Head of Account and the SNA–SPARSH module only.

3. As per the proposal of the Director, Scheduled Castes Development Department orders issued re-appropriating an amount of ₹55,00,000/- (Rupees Fifty Five Lakh only) from the Head of Account 2225-01-800-86-01 (PV) to 2225-01-800-86-02 (PV) for the Financial Year 2025-26 , vide Government order read as 4th paper above .

4. As per the letter read as 5th paper above, the Director, Scheduled Castes Development Department has requested Government to accord Sanction for an amount of ₹54.166 lakh (Rupees Fifty Four Lakh Sixteen Thousand Six Hundred only) comprising ₹27.0830 lakh as Central share and an equal amount as matching State share, for the implementation of schemes under the Protection of Civil Rights Act, 1955 and the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989 through SNA-SPARSH.

5. Government have examined the matter in detail and are pleased to **accord sanction for release of an amount of ₹54.166 lakh (Rupees Fifty Four Lakh Sixteen Thousand Six Hundred only)** to the **Scheduled Castes Development Department** for the implementation of schemes under the **Protection of Civil Rights Act, 1955** and the **Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989**, subject to the condition that the expenditure shall be met from the appropriate Head of Account and the funds shall be utilized strictly in accordance with the scheme guidelines through the **SNA-SPARSH module**.


