ORDER

As per the letter read as 1 st paper above, the Director ,Agriculture Development and Farmers Welfare Department has submitted a proposal for Administrative Sanction for an amount of Rs. 450 lakhs based for VAIGA 2026. The expenditure was proposed to be met from the budget provisions under “Strengthening of Agricultural Extension” under the H/Ac 2401-00-109-80, for Rs. 50 lakhs, budget provisions under “Green Coconut procurement through VFPCCK” under the H/Ac 2435-01-101-73 for Rs. 300 lakhs and through corporate and institutional sponsorships and previous VAIGA bank balance for 100 lakhs. As per the G.O. read as 2nd paper above sanction was issued to release of Rs. 100 lakhs from Green Ccoconut procurement in the H/Ac 2435-01-101-73 and Rs. 50 lakhs from Strengthening of Agricultural extension in the H/Ac 2401-00-109-80. The VAIGA 2026 program was successfully conducted during February 11 th to 16th, 2026 and a total expenditure of Rupees 387.6673 lakhs was actually incurred. Accordingly as per the G.O. read (3) above sanction was accorded for release of Rs 31.21 lakhs , being the balance amount required after meeting the expenditures from the funds already released and sponsorships received. Therefore the Director as per letter read as 4th above has submitted a proposal for Administrative Sanction based on the actual expenditure incurred ie. Rs 387.6673 lakhs sourcing funds as detailed below .

1. Strengthening of Agricultural Extension” H/Ac 2401-00-109-80 Rs 50 lakhs
2. Green Coconut procurement through VFPCCK” H/Ac 2435-01-101-73 Rs 131.21 lakhs

3. Balance available in VAIGA Bank Account and Institutional and corporate sponsorships received as well as expected and revenue through stall rent & ticket charges collected Rs 206.45943.


