### ORDER

(1) The Director, Scheduled Tribes Development Department as per the letter read above has submitted the proposal for providing financial assistance to landless Scheduled Tribes families in the State to purchase land for construction of houses at an estimated cost of Rs. 14,96,25,000/- (Fourteen Crore Ninety Six Lakh and Twenty Five Thousand Only) to Government for placing before the State Level Working Group Committee.

(2) The State Level Working Group held on 24/02/2026 considered the said proposal and recommended approval of the proposal for providing financial assistance to landless ST families in the State to purchase land for construction of houses.

the proposal for providing financial assistance to landless ST families in the State to purchase land for construction of houses at estimated cost of ₹ Rs. 14,96,25,000/- (Fourteen Crore Ninety Six Lakh and Twenty Five Thousand Only).
