ORDER

In the Annual Plan Budget 2025-26 a total amount of Rs.3500 Lakh has been provided to Malabar Cancer Centre under the Head of Accounts '2210-05-200-96-35 (P) - Grants for the creation of Capital Assets' (Rs.2100 Lakh) & '2210-05-200-96-36 (P) - Grant-in-Aid - General - Non Salary)' (Rs.1400 Lakh) for the implementation of the Scheme 'Assistance to Malabar Cancer Centre'. Out of this, the resumed amount of Rs.3,73,49,471/- [Rs.3,37,70,492/- under 2210-05-200-96-00-35(PV) and Rs.35,78,979/- under 2210-05-200-96-00-36(PV)] was reallocated to MCC vide Government Order read as paper 1st above. Later, vide Government Order read as paper 2nd above, Administrative Sanction was accorded for an amount of Rs.3500.00 lakh under the head of account '2210-05-200-96 (PV)' during the Financial Year 2025-26 [Rs.21 crore under 2210-05-200-96-35 and Rs.14 crore under 2210-05-200-96-36]. Subsequently, vide Government Order read as paper 3rd above, a total amount of Rs.10,89,34,000/- was released under the head of account '2210-05-200-96(PV)' to Malabar Cancer Centre (Rs.9,89,34,000/- from the head of account '2210-05-200-96-35' and Rs.1,00,00,000/- from the head of account '2210-05-200-96-36').

2. As per the letter read as paper 4th above, the Director, MCC has

requested to release the balance amount of Rs.7,72,95,508/- under the head of account '2210-05-200-96-35(P)' during the Financial Year 2025-26.

3. Government have examined the matter in detail. Accordingly, sanction is hereby accorded to **release Rs.7,72,95,508/- (Rupees Seven Crore Seventy Two Lakh Ninety Five Thousand Five Hundred and Eight Only)** under the head of account '**2210-05-200-96-35(P) - Grants for the creation of Capital Assets**', subject to the following terms and conditions:

- i. The amount released shall be transfer credited to PSTSB account in compliance of GO(P)62/2018/Fin dated 16/04/2018.
- ii. The instructions in Circular No.84/2008/Fin dated 09/12/2008, Circular No.8/2018/Fin dated 30/01/2018 & G.O(Ms) No.93/2020/Fin dated 11.09.2020 shall be scrupulously followed.
- iii. The Director, MCC shall furnish duly authenticated detailed component wise statement of expenditure and Utilization Certificate as per instructions in GO.(Ms)No.4/2020/Fin dated 09/01/2020.
- iv. If there is un-utilized amount at the end of this financial year that should be refunded to the Government during the financial year itself.
