### ORDER

An amount of ₹ 887.29 lakh was released to the Kerala Rural Water Supply and Sanitation Agency (Jalanidhi) from the total outlay of ₹.2961 lakh earmarked for implementation of the scheme "Sustainability Support to Community Managed Water Supply Schemes" under the Head of Account 2215-01-102-80 (P) for the year 2025-26 vide Government Orders cited above .

2. The Executive Director, Jalanidhi has informed, vide letter cited as (4) above, that out of the released amount ₹ 887.29 lakh an amount of ₹773.96 lakh was incurred as expenditure and an amount of ₹113.34 lakh retained in the PSTSB Accounts as on 31.03.2026 was resumed by Government. He has therefore requested to release the resumed fund of ₹1,13,33,746/- for the timely disbursement of salary and administrative expenses for the months of March to May 2026 under the above scheme.

3. In the 2026-27 Budget, an amount of Rs.3100 lakh has been earmarked under the Head of Account 2215-01-102-80-00 (P) for the implementation of the "Sustainability Support to Community Managed Water Supply Schemes"

4. Government have examined the matter in detail and are pleased to reallocate the resumed amount of ₹1,13,33,746/- (Rupees One

Crore Thirteen Lakh Thirty Three Thousand Seven Hundred and Forty Six Only) from the current year's budget provision under the Head of Account 2215-01-102-80-00 (P) and release the said amount for meeting the disbursement of salary and administrative expenses in connection with the implementation of the 'Sustainability Support to Community Managed Water Supply Schemes'.
