ORDER

The Ministry of Rural Development, GoI, as per letter read as 2nd paper above, had sanctioned an amount of ₹34.15 crore (₹33.38 Crore for the Programme Fund and ₹0.77 Crore for the Admin Fund) towards the Mother Sanction to the State as Central Assistance under Pradhan Mantri Gram Sadak Yojana (PMGSY) during the Financial Year 2026-27. Accordingly the Chief Engineer, KSRRDA has, as per letter read as 3rd paper above, reported that the matching State share is ₹22.78 Crores (₹22.25 Crore for the Programme Fund and ₹0.51 Crore for the Admin Fund) and requested to release the Central Share along with matching State Share.

2. Government have examined the matter in detail. The Central share and the matching State Share in the ratio of 60:40 has been worked out as follows :

On the basis of the calculation given in the above table, Government are pleased to accord sanction to release a total amount of ₹56,91,66,666/- (Rupees Fifty Six Crore Ninety One Lakh Sixty Six Thousand Six Hundred and Sixty Six only) towards the Mother Sanctioned Central share and its corresponding State share of Programme & Admin Fund for the FY 2026-27 for the implementation of PMGSY in the State, from the current Year's budget provision by debiting from the head of account 4515-00-800-98 (02), subject to the conditions stipulated in the Circular read as Ist paper above.
