ORDER

The PMGSY III (2021-22) work of Package No.KR 01-80 Bharanikavu Block in Alappuzha was sanctioned for a total length of 4573 m out of which 3133 m road was completed under PMGSY. Out of the balance 1440 m length, 1260 m was completed by Rebuild Kerala Initiative Scheme and 180 m was completed by Bharanikav Grama Panchayat. Therefore the PMC meeting held on 17/3/2025, decided to exclude 1440 m length from PMGSY. The Chief Engineer, KSRRDA, as per letter read above has reported that the total amount for the PMGSY work (4573m) comes to Rs.2,88,08,301/- (Construction Cost) and an amount of Rs.87,45,972/- is available in the project itself due to the non execution of the work under PMGSY. The CE also reported that the total expenditure incurred for the work was ₹2,48,36,000/-. The Chief Engineer, KSRRDA has requested to grant permission for foreclosing the work since partial length was completed in other schemes.

2) Government have examined the matter in detail and are pleased to accord sanction for foreclosing the work "PMGSY-III 2021-22 (Batch-1) Package No. KR.01-80 Bharanikavu Block, Alappuzha" subject to the following conditions;

i) The Chief Engineer, KSRRDA shall ensure that the non-execution of 1440m length of road is not due to the fault of the contractor and no loss has occurred to the State exchequer.

ii) Necessary permission from NRIDA may be obtained without any additional burden to the State.
