As per the Government order read as 1st paper above, Government have ordered to market timber and other produce through online by utilising the services of M/s. MSTC Limited, Kolkatta. As per the Government Order read as 2nd paper above, permission was accorded to continue the present system of e-auction for a further period of 1 year from 29.3.2021.

2) As per letter read as 3rd paper above, the Principal Chief Conservator of Forests (Forest Management) has informed that the department is auctioning materials worth 300 Crores every year, and hence a reliable platform is required to avoid loss of revenue. PCCF recommended that M/s MSTC Ltd, a Government of India enterprise, has been delivering satisfactory Therefore, the Principal Chief years. these all services Conservator of Forests (Forest Management) has requested to permit the Kerala Forest Department to avail the service of M/s MSTC Ltd for e-auction by paying 0.8% Service Charges for a further period of one year from 29.3.2022 and to renew the selling Agency Agreement.

and hereby grant permission to avail the services of M/s. MSTC Ltd for e-auction, by paying 0.8% service charges for a further period of one more year from 29/3/2022 in the Forest Department by renewing the selling agency agreement with the agency.
