**ORDER**

As per the Government Order read as 1<sup>st</sup> paper above, Administrative Sanction was accorded for an amount of Rs. 2 crore for project preparatory expenses for the financial year 2024-25 from the H/A "5051-80-190-97-01-Azhikkal Port Limited - Development of Greenfield Port (PV). As per the Government Order read as 2<sup>nd</sup> paper above, an amount of Rs.1.39 Cr. was released to MIPSL for project preparatory expenses for the financial year 2024-25 under the H/a 5051-80-190-97-01-(PV) for the component payment to CMD, Statutory fee for CRZ compliance, Payment to CMD-EoI and Transaction Advisory and Payment to KITCO.

2. The M.D. & C.E.O MIPSL as per the letter read as 3<sup>rd</sup> paper above, reported that the sanctioned funds were not released to the account of MIPSL. Hence the M.D. & C.E.O MIPSL requested to release the sanctioned amount of Rs. 1.39 crores to the PSTSB account no. 799012700000156 of Malabar International Port & SEZ Ltd with the Principal Sub-Treasury, East Fort, Thiruvananthapuram from the Budget allocation for the FY 2025-26 under the HoA 5051-80-190-97-01-(PV) - Malabar International Port & SEZ Limited - Development of Green Field Feeder Port.

3. Government have examined the matter in detail and are pleased to

accord Administrative Sanction for an amount of Rs. 1.39 crores (Rupees One crore and Thirty Nine Lakhs only) for the components - payment to CMD, Statutory fee for CRZ compliance, Payment to CMD-EoI and Transaction Advisory and Payment to KITCO for the financial year 2025-26, from the H/A "5051-80-190-97-01-(PV) -Malabar International Port & SEZ Limited-Development of Green Field Feeder Port (PV).

4. The M.D. & C.E.O Malabar International Port & SEZ Ltd. should furnish separate proposal for fund release.
