ORDER

The Chief Engineer (Road), as per the letter read above, has requested to accord Administrative Sanction for the work "Budget work 2019-20-Widening, Improvement and Extension of Existing road from Keezhattoor Junction to NH 66 from KM 0/000 to 1/200 " in Thaliparamba Legislative Assembly Constituency for an amount of ₹ 800 Lakh under the h/a 5054-04-337-99-MDR.

2) Government have examined the matter in detail and are pleased to accord sanction for the work "Improvement and Extension of existing road from Keezhattoor Junction to NH- 66 Km 0/000 to 1/200" for an amount of ₹.800 Lakh (Rupees Eight Crore only) under the Head of Account 5054-04-337-99-MDR ,subject to the following conditions:

- i. The correctness of the rates adopted for observed data included

in the estimates shall be ensured by the TS authority.

ii. TS authority shall ensure the necessity of demolishing/ dismantling the existing structures before issuing TS.

iii. The competent authority shall ensure the admissibility of provisions included in the estimate with the site conditions before issuing the Technical Sanction.

iv. The total amount earmarked for land acquisition as per DPR is Rs. 6.00 crores and the amount shall not re-appropriated by TS authority for other items of works.

v. Where dismantling of existing DR masonry structures shall be necessitated as per site conditions, the rubble so obtained shall be reused and accounted as departmental rubble.

vi. The Structural provisions given for the drain, culverts shall be ensured by the TS authority before according TS and shall meet the requirements as per IRC.
