As per the Government Order, read as 1st paper above, sanction was accorded for setting up Waste to Energy (WtE) Plants in the State including Palakkad , on Design, Build, Finance, Operate and Transfer (DBFOT) basis in Public Private Partnership (PPP) mode.

(2) As per letter, read as 2nd paper above, Project Director, PMU-WtE Projects, KSIDC reported that the Concessionaire for WtE Project at Palakkad, after securing all requisite statutory clearances to commence construction and after achieving financial closure for the project, has now commenced construction activities at the site from September, 2024 and the project is progressing as per the approved timeline, with major milestones being met as scheduled. Completion of critical infrastructure components is anticipated in the coming months.

(3) To ensure effective supervision and monitoring of project

development and operations, as well as co-ordination among stakeholders, Project Director, WtE Projects proposed to constitute a State Level Project Monitoring Committee (PMC).
