ORDER

The candidates, Sri Akhil T.S and Sri Prabinson Horassio N., advised by the Kerala Public Service Commission vide the letter read as read 3rd paper above were appointed temporarily as Assistant Public Prosecutor Grade-II in the Kerala State Prosecution Service as per order read as 4th paper above.

2. However six Assistant Public Prosecutors who had served as temporary Civil Judges (Junior Division) in the District Judiciary were repatriated to parent department and hence the above mentioned junior most officers were discharged from service for want of vacancies, as per the order

read as 5th paper above. Now the Director General of Prosecution as per the letter read as 6th paper above has requested Government to take necessary steps to re-appoint the discharged candidates in the vacancies arose due to promotion in the Prosecution Department.

3. Government have examined the matter in detail and the undermentioned candidates are hereby re-appointed temporarily as Assistant Public Prosecutor Grade-II in the Kerala State Prosecution Service and are posted to the vacancies noted against their names, in accordance with Rule (7) (b) Part II of the KS& SSR, 1958, Rule (9) (a) (i) of the KS&SSR, 1958, and subject to the conditions specified in clause (iii) of Rule 10(b) and 3(c) of said Rule, in the scale of pay of Rs.56500-118100 (Pre-revised 40500-85000). As per the second proviso to sub-rule (b) of rule 7 Part II, Kerala State and Subordinate Service Rules, 1958 they continue as probationers in the post, Assistant Public Prosecutor Grade II, from which they were discharged.
