ORDER

The undermentioned candidates advised by the Kerala Public Service Commission, Thiruvananthapuram, as per letter read above are hereby appointed temporarily as Assistant Public Prosecutor Grade-II in the Kerala State Prosecution Service. They are posted to the vacancies noted against their names, in accordance with Rule (9) (a) (i) of the KS&SSR, 1958, subject to the conditions specified in clause (iii) of Rule 10(b) and 3(c) of said Rule, in the scale of pay of Rs.56500-118100 (Pre-revised 40500-85000).

- 2. The candidates are directed to report before the Director General of Prosecution, Ernakulam, with original documents regarding proof of age, income, community and educational qualifications within 15 days from the date of receipt of this order. The candidates shall also produce a Medical Certificate as prescribed in the government order read as Ist paper above. The Director General of Prosecution shall verify the above documents before admitting the candidate for duty. He shall verify the Income Certificate and Community Certificate of the candidates concerned at the time of joining duty.
- 3. The Director General of Prosecution shall satisfy himself of the identity of the candidates based on the verification certificate (One Time Registration) before they are allowed to join duty. There is a signature of the candidate on the passport size photograph affixed to the verification certificate. The photograph and signature of the candidates should be verified by the Director General of Prosecution and the fact may be recorded by him in the original verification certificate (One Time Registration) itself. If there is any discrepancy, the candidates should not be allowed to join duty and the fact should be reported to the government immediately.
- 4. It may be informed to the government (a) if the candidates fail to comply with the rules as to health (b) if the candidates are rejected on the ground of character and/or antecedents and (c) in case of compliance, the date on which the candidates joined duty. The date of reporting of the above candidates before the Director General of Prosecution and the date of joining in the court concerned should be reported to the government immediately after the candidates reported before the Director General of Prosecution. In case the candidates do not join duty within the joining time allowed in the appointment order, the details should be reported to the

government in the proforma promptly, ie. immediately after the expiry of the joining time allowed.

- 5. The proforma as per Government order read as 2 nd paper above should also be duly filled up and signed by the candidates and produced at the time of reporting for duty. The Director General of Prosecution shall obtain this from the candidates and forward the same to the government along with the duly filled up original verification certificate (One Time Registration) for onward transmission to the Kerala Public Service Commission. The appointment will be regularized only after the receipt of verification certificate from the Kerala Public Service Commission for this purpose.
- 6. In the event of discharge from service for want of vacancies, the candidates may either re-register their name in the Office of the Kerala Public Service Commission from where they are advised and get themselves re-appointed on further advice by the Kerala Public Service Commission, or they may wait for their turn for re-appointment to the post in the Department in case they desire to continue as probationer in the post from which they were discharged.
- 7. The Director General of Prosecution, being satisfied on verification the documents produced by the candidates, should arrange for the training of the recruits for 180 working days from the date of joining duty after getting an agreement executed by them as prescribed in Rule 12 of Special Rules. During the period of training, the trainees shall be paid only the training allowances and TA & DA admissible to Grade-II Officers for journey in connection with the training. The Period of training including examination, the period of extension of training, if any, shall be treated as officiating service for the purpose of increment, pension and probation. On completion of the training period, they shall be on probation for a total period of two years on duty within a continuous period of 3 years, during which they will have to pass the Account Test for Executive Officers of the Kerala State or the Account Test (Lower) of the Kerala State, if they had not already passed any of these tests.
