Medical College, Kollam with M/s KEXCON for a period of one more year from 24.04.2026 for an amount of

Rs.2,38,14,437/- (Rupees Two Crores Thirty Eight Lakhs Fourteen Thousand Four Hundred and Thirty Seven Only). It is also reported that the required fund in this regard can be met from the Plan funds under the H/a "2210-05-105-53-34-OC(P)".

Government have examined, the matter in detail and are pleased to accord sanction for the renewal of outsourced service contract of 70 security personnel with M/s KEXCON for a period of one year, **w.e.f 24.04.2026 for an amount of Rs.2,38,14,437/-(Rupees Two Crore Thirty Eight Lakh Fourteen Thousand Four Hundred Thirty Seven Only)** (effecting the revision from Rs.800/- to Rs.840/- per day in accordance with G.O.(P)No.24/2026/Fin Dated:18/02/2026) by meeting the expenditure from the budget provision under the H/A '2210-05-105-53-34-OC(P)'.
