## **ORDER**

As per the Government Order read as 1<sup>st</sup> paper above, Leave Without Allowance otherwise than on Medical Certificate under Rule 88 Part I KSRs was granted to Smt.Annamma Philip,Research Officer, District Planning Office, Idukki for the period from 19.01.2008 to 27.03.2009 and orders issued accordingly. Against this Order, the Applicant filed OA (EKM) No.696/2014 and as per the final order dated 16.11.2017, the Hon'ble Kerala Administrative Tribunal directed the 1<sup>st</sup> respondent, ie; Government, to take a fresh decision on the claim of the applicant to sanction her Leave Without Allowance on Medical Grounds with effect from 19/01/2008 to 27/03/2009. Government complied with the direction of the Hon'ble Kerala Administrative Tribunal as per the Government Order read as 2<sup>nd</sup> paper above, by rejecting the request of the Applicant.

2. Aggrieved by this decision, the Applicant, Smt.Annamma Philip, Joint Director (Retired), State Planning Board again filed OA.No.2148/2021 before the Hon'ble Kerala Administrative Tribunal. The Hon'ble Kerala Administrative Tribunal as per the Order read as 3<sup>rd</sup>

paper above have set aside the Government Order read as 2<sup>nd</sup> paper above and directed Government to grant LWA on medical certificate, to the applicant, for the period from 19.01.2008 to 27.03.2009 within a period of 2 months from the date of receipt of a copy of this Order.

- 3. Government have examined the matter in detail and are pleased to grant Leave Without Allowances on medical certificate to Smt. Annamma Philip, Joint Director (Retired), State Planning Board for the period from 19.01.2008 to 27.03.2009 under Rule 88 Part I KSRs subject to the condition that the leave period cannot be considered for the accrual of Earned leave.
- **4.** The G.O read as 1<sup>st</sup> paper above stands cancelled.
- **5.** Final Order of the Hon'ble Kerala Administrative Tribunal in OA.No.2148/2021 is complied with accordingly.
