ORDER

As per the Government Orders read as 1st and 2nd above, administrative sanction has been accorded for the projects “Alternative & Supportive Livelihood Opportunity to Fisher Women of Kerala 2025–26” for an amount of Rs. 1,400 lakhs and “Strengthening SAF Fisher Women Micro Enterprises through Collectivization and Value Chain Development 2025–26” for an amount of Rs. 756.01 lakhs.

2) As per the Government Order read as 3rd above, sanction has already been accorded for the release of an amount of Rs. 3,00,00,000/- (Rupees Three Crore only) for the implementation of the project “Alternative and Supportive Livelihood Opportunity to Fisher Women of Kerala 2025–26.” However, though an amount of Rs. 300 lakhs was sanctioned, the same could not be allotted due to the ceiling limit under the Head of Account ‘2405-00-103-80 (P)’. The delay in fund allotment is holding up beneficiary-level activities and adversely affecting livelihood support to fisher women.

3) Hence, the Director of Fisheries, as per the letter read above, has submitted a proposal for the projects “Alternative and Supportive Livelihood Opportunity to Fisher Women of Kerala 2025–26” and “Strengthening SAF Fisher Women Micro Enterprises through Collectivization and Value Chain Development 2025–26” and has requested to sanction and release an amount of Rs. 500 lakhs to the PSTSB Account

No. 799012700000787 of the Executive Director, SAF, Sub Treasury, Aluva, for the timely implementation of SAF projects.

4) Government have examined the matter in detail and are pleased to accord sanction to release an amount of Rs. 200 lakhs (Rupees Two Hundred Lakh only) under the Head of Account '2405-00-103-80-00-00-P-V' for the implementation of the project "Strengthening SAF Fisher Women Micro Enterprises through Collectivization and Value Chain Development 2025-26."

5) Government further order that the ceiling limit under the Head of Account '2405-00-103-80-00-00-P-V' is enhanced to 61.21%, thereby enabling allocation of a total amount of Rs. 5.00 crore (Rupees Five Crore only) for the implementation of the said projects during the year 2025-26.

6) The Director of Fisheries shall take further necessary action for the implementation of the above projects in accordance with the existing rules, guidelines, and budget provisions and shall ensure proper and timely utilisation of funds.
