ORDER

As per the letter read as 4th paper above, Government of India have provided Mother Sanction for release of funds under SNA SPARSH model for an amount of ₹22.73 Crores as Central share for implementation of Annual Action Plan 2024-25 for different schemes under Krishonnati Yojana in which Central share of ₹ 15 Crores was allotted under the General, SC and ST category as the second installment for implementation of the scheme MIDH through SPARSH during the current year. The category wise split up of funds under various categories for the scheme components including the State share is as follows:

- 2. As per letter read as 8th paper above, the Director of Agriculture has informed that the scheme is intended to be implemented in the State for the activities listed in the plan approved by SLSC. As per the clause 3, vii of Circular read as 6th paper above, Finance Department has issued directions for management of funds through SPARSH platform enabling "Just in Time" release of funds through an integrated system of IFMS and PFMS. Director of Agriculture as per the letter read as 8th paper above has informed that there is no sufficient budget provision available under the heads of account for the scheme and hence has requested to reappropriate the entire amount available in Central heads to the corresponding State heads and issue additional authorisation.
- 3. As per Government Order read as 9th paper above, an amount of ₹8,00,00,000/- (Rupees Eight Crore only) was re appropriated to the respective State head of accounts and as per Government Order read as 10th paper above, an amount of ₹11,68,88,000/- (Rupees Eleven crore Sixty Eight Lakh Eighty Eight Thousand only) was additionally authorised to facilitate the release of the Second installment of the Central and corresponding State shares for the General, SCP, and TSP components of the Scheme, Mission for Integrated Development of Horticulture.
- 4. Government have examined the matter in detail and are pleased to accord sanction to the Director of Agriculture to release an amount of ₹25 Crores (Rupees twenty five crores only) as second installment of funds for implementation of the scheme KY- MIDH 2024-25 through SPARSH as detailed in the table below:

- 6. The Director of Agriculture after completion of the financial year should prepare a reconciled Statement of Expenditure (SoE) and furnish the same to Accountant General (Audit) as stipulated in Government Order read as 1st to 3rd papers above.
