ORDER

The Chief Engineer (Administration) vide reference 1st cited above has submitted proposal for blacklisting the contractors who regularly fails to complete the works in time and violate the norms for execution of works without any valid reason, and whose contracts has been terminated at the risk and cost of contractor.

2) Government have examined the matter in detail and here by accord sanction to amend the following clauses of Kerala Public Works Department (KPWD) Manual as follows:

- 3) The following two points are added as the reason for blacklisting of Contractor by the Registering authority as reason number (vii) and (viii) in Clause 1917.
- (vii) The Contractor who has been terminated at the risk and cost of contractor thrice, in accordance with clause 2116.2, shall be blacklisted.
- (viii) When the Competent Authority recommends for blacklisting the Contractor (lowest successful bidder) after the lowest successful bidder fails to enter into agreement for works costing below Rs.5 crore with in the allowed time (including allowed extended time for entering into agreement) as per KPWD Manual Cl 2009.6.

The sentence 'Blacklisting of contractors shall be done only by considering the principles of natural justice' shall also be added in Clause 1917.

The Chief Engineer, Administration, PWD shall take necessary steps regarding the matter.
