ORDER

As per Government order read as 1st above, Comprehensive Administrative sanction for an amount of ₹10960 lakhs was accorded for the construction of new campus for Indian Institute of Information Technology and Management-Kerala(IIITM-K). Subsequently, administrative sanction for an amount of ₹898 lakhs was issued as per G.O read as 2nd paper above for the scheme in the FY 2024-25.

2. The Director, IIITM-K as per the letter read above has submitted proposal for the scheme "Creation of New campus for IIITM-K in

Techno city" amounting to ₹1595 Lakhs for according administrative sanction for the financial year 2025-26. The Special Working Group meeting held on 22.05.2025, approved the above scheme and recommended to issue administrative sanction for the current financial year.

3. Government have examined the matter in detail and are pleased to accept the recommendation of the Special Working Group meeting held on 22.05.2025 and to accord administrative sanction for an amount of ₹1595 Lakhs (One Thousand Five Hundred Ninety-Five Lakhs only) for the implementation of the plan scheme "Creation of New campus for IIITM-K in Techno city" for the financial year 2025-26, as detailed below;

Objective:- Construction of a full fledged and independent residential campus for IIITM-K (to be transformed as Digital University Kerala) at Technocity.

The above schemes shall be implemented adhering to the following conditions:

- The expenditure shall be met from the provision available under the Head of Account 4859-02-190-93 (P).
- Fund release will be based on actual requirement and the fund released should not be parked in banks.
- Store purchase rules should be strictly adhered to.
- Tender/ e-tender and other stipulated formalities shall be followed wherever necessary.

• Post creation and purchase of vehicle are not admissible under the scheme.

4. The Director, Indian Institute of Information Technology and Management- Kerala (IIITM-K) shall follow all the prescribed guidelines, rules, other formalities and procedures for implementation of the scheme. Proposals for release of funds should contain break up of expenditure, report on the component wise expenditure of funds released during the previous year and component wise Utilization Certificates in the prescribed proforma. Funds will not be released in case of any procedural laxity or violation.
