## **ORDER**

As per letter read above, the Chief Engineer, Buildings has furnished a detailed estimate amounting to ₹300 Lakhs for the 'Construction of Shopping Complex and Renovation of Market at Poonkavu, Pathanamthitta' prepared based on the 2018 DSR and 18% GST for according Administrative Sanction.

- 2. Government have examined the matter in detail and are pleased to accord Administrative Sanction for the "Construction of Shopping Complex and Renovation of Market at Poonkavu, Pathanamthitta" for an amount of Rs. 300 lakhs (Rupees Three Hundred Lakhs Only), under the H/A 4059-60-051-86-00-16-00-P-V, subject to the following conditions:
- 1. The soil investigation as well as structural design is not included in the DPR and hence T.S authority shall ensure foundation requirements, structural adequacy and structural stability before issuing the Technical Sanction considering economy.
- 2. The grade of concrete to be considered for the proposed construction shall be reviewed as per IS code while issuing T.S.
- 3. The competent TS authority shall ensure the admissibility of provisions included in the estimate with the site conditions before issuing Technical Sanction.
- 4. The works proposed in the estimate shall satisfy the functional

requirements as envisaged along with adequate safety features.

5. Lump sum provision is provided for electrification; hence, detailed estimate shall be prepared before issuing TS.

The Chief Engineer, Buildings, PWD shall ensure that the aforesaid conditions are adhered to.

3. The expenditure for the above purpose will be debited under the H/A - 4059-60-051-86-00-16-00-P-V.
