## <u>ORDER</u>

As per letter read as 1st paper above, the Chief Engineer, Buildings has furnished a detailed estimate amounting to ₹200 Lakhs for 'Renovation of buildings and infrastructure developments of Govt. ITI, Chengannur' prepared based on the DSR 2018 & GST 18% for according Administrative Sanction, under the head of account 4059-01-051-86. Thereafter, vide letter read 2nd paper above, Chief Engineer (Buildings) informed that the amount required for the proposed ITI is to be debited from the head of account - 4202-02-105-85-ITI Buildings'.

2) Government have examined the matter in detail and are pleased to accord Administrative Sanction for 'Renovation of buildings and infrastructure developments of Govt. ITI, Chengannur' for an amount of ₹200 Lakhs, (Rupees Two Hundred Lakhs Only) under the Head of Account 4202-02-105-85-ITI Buildings subject to the following conditions:

1. The works proposed in the estimate shall satisfy the functional requirements as envisaged.

2. The competent TS authority shall ensure the admissibility of provisions included in the estimate with site conditions before issuing Technical Sanction.

3. The retaining wall proposal shall be in accordance with Circular No.64/2021/Fin dated 05/08/2021.

4. The correctness of the rates adopted for observed data included in the estimate shall be ensured by the TS authority.

The Chief Engineer, Buildings, PWD shall ensure that the aforesaid conditions are adhered to.

3) The expenditure for the above purpose will be debited under the H/A - 4202-02-105-85-ITI Buildings.
