### ORDER

As per letter read above, the Registrar (Finance), High Court of Kerala informed the government that the Deputy Collector (General), Kottayam had requested to remit the arrears of water charges of the District Court, Kottayam, the Sub Court, Kottayam and the Munsiff's Court, Kottayam (which are all accommodated in the Civil Station, Kottayam), for the financial year 2023-2024. The arrear comes to a total of Rs. 3,62,045/- (Rupees Three Lakh Sixty Two Thousand and Forty Five Only) due for the period from 26.04.2023 to 27.02.2024.

2.Since the requested amount exceeds the financial powers delegated to the High Court, vide government order read above, Registrar requested the government to accord Administrative Sanction for the payment of arrears of water charges of the said courts of Rs.3,62,045/- (Rupees Three Lakh Sixty Two Thousand and Forty Five only) by meeting the expenditure under the head of account "2014-00-105-99-00-05-01-Water Charges".

3. Government have examined the matter in detail and are pleased to accord sanction for the payment of arrears of water charges pertaining to the District Court, Kottayam, the Sub Court, Kottayam and the Munsiff's Court, Kottayam for the financial year 2023-2024 amounting to a total of Rs. 3,62,045/- (Rupees Three Lakh Sixty Two

Thousand and Forty Five only) due for the period from 26.04.2023 to 27.02.2024.

4.The expenditure shall be met from the head of account "2014-00-105-99-00-05-01-Water Charges".
