On submission of the invoice read as 1<sup>st</sup> paper, the Department of Post was sanctioned ₹ 2,44,65,738/- (Rupees Two Crore Forty Four Lakh Sixty Five Thousand Seven Hundred and Thirty Eight Only), towards the booking of EPICs for the Month of March 2026, vide Government Order read above. However, later it was come to notice that there was an error occurred in the invoice and accordingly Department of Posts, India has submitted a revised invoice vide reference 3<sup>rd</sup> cited above. The revised Invoice amounts to ₹ 2,43,40,126/- (Rupees Two Crore Forty Three Lakh Forty Thousand One Hundred and Twenty Six Only) including GST for the booking and delivery of 8,25,089 EPICs during the Month of March, 2026.

2) Government have examined the matter in detail and are pleased to cancel the Government Order read as 2<sup>nd</sup> paper and accord sanction for the payment of ₹ 2,43,40,126/- (Rupees Two Crore Forty Three Lakh Forty Thousand One Hundred and Twenty Six Only) as postage charges for the booking and delivery of 8,25,089 EPICs for the month of March, 2026.
