ORDER

As per the Government Order read as 2nd paper above, Administrative sanction was accorded for shifting of Sub Regional Transport Office Vellarikkundu to Mini Civil Station by District Nirmithi Kendra Kasargod for an amount of Rs.10,58,000/- (Rupees Ten lakhs Fifty Eighty thousand only).

2) The Transport Commissioner as per the letter read 1st paper above has informed that while administrative sanction of ₹10,58,000 was originally accorded based on DSR 2018, DSR 2021 rates came into effect in the State on 01.04.2025 as per G.O.(P) No. 21/2025/Fin dated 26.02.2025; consequently, the District Nirmithi Kendra, Kasaragod informed that executing the agreement for shifting the Vellarikundu Sub RTO to the Mini Civil Station is only possible if the revised estimate of ₹12,34,000 under DSR 2021 is sanctioned.

3) Government have examined the matter in detail and are pleased to accord revised administrative sanction for shifting of Sub Regional Transport Office, Vellarikkundu to Mini Civil Station by District Nirmithi Kendra Kasaragod for an amount of Rs.12,34,000/- (Rupees Twelve lakh Thirty Four Thousand Only) against the previously sanctioned amount of Rs. 10.58 lakhs, by debiting the expenditure to the h/a 2041-00-001-99-00-

34-03-N-V, subject to the following conditions;

- Motor Vehicles Department shall ensure that the works proposed in the estimate shall satisfy the functional requirements as envisaged .
- Nirmithi Kendra shall be advised to take up any structural works with the consent of KPWD units in charge of Mini civil station.
- The Transport Commissioner shall adhere to all Government Orders pertaining to the accredited agencies while executing the works through Government approved accredited agencies.
