### ORDER

WHEREAS, it has been disclosed from the records of investigation in Crime No.484/2018 that a case was registered at Kasaragod Police Station on the basis of a complaint stating that the complainant's daughter Nasira, 25 years old, her husband Mohammed Sabad M P and 3 children, Sabad's 2<sup>nd</sup> wife Raihanath and his friend Anzar, his wife and 2 children have been found missing since 15/06/2018 after leaving to Gulf. During the course of investigation, it was revealed that the missing persons [A1] Mohammed Sabad Moideenkutty Pudiyapura, S/o M.P. Ashraf, Valiyavalappu House, Mogral, Kumbla Village, Kasaragod District, holder of Indian Passport bearing No.L 8575858 [A2] Nasira Anebagilu Hameed, W/o Mohammed Sabad Moideenkutty Pudiyapura, Valiyavalappu House, Mogral, Kumbla Village, Kasaragod District, holder of Indian Passport bearing No. N 8490180 [A 3] Raihanath Chakkamthodi, W/o Mohammed Sabad Moideenkutty Pudiyapura, Chakkamthodi House, Edathanattukara, Palakkad District,

holder of Indian Passport bearing No.N 9552564 [A4] Mohammed Ansar Aboobacker, S/o Aboobacker, Fathima Manzil, Agarthimoola, Bekur Village, Kasaragod District, holder of Indian Passport bearing No.P 7581550 & [A5] Zeenath Kollambady Abdulkareem, W/o Mohammed Ansar Aboobacker, Fathima Manzil, Agarthimoola, Bekur Village, Kasaragod District, holder of Indian Passport bearing No. P 7567037 had traveled to Yemen from Gulf for religious studies and were residing there. The investigation has established that the above mentioned accused persons illegally traveled to Yemen on 07.06.2018, in violation of the prohibition on Indian citizens from traveling to Yemen, as per Government of India Notification No. S.O. 3223(E) dated 26.09.2017. Thus the accused persons [A1] Mohammad Sabad Moideenkutty Pudiyapura, [A2] Nasira Anebagilu Hameed, [A3] Raihanath Chakkamthodi, [A4] Mohammed Ansar Aboobacker & [A5] Zeenath Kollambady Abdulkareem have violated the provisions of Passport Act and Rules and have committed offences punishable under section 12(3) of the Indian Passport Act, 1967.

AND WHEREAS, the Government of Kerala after careful examination of the records of investigation in Crime No. 484/2018 of Kasaragod Police Station are fully satisfied that the aforesaid accused persons [A1] Muhammad Sabad Moideenkutty Pudiyapura, [A2] Nasira Anebagilu Hameed, [A3] Raihanath Chakkamthodi, [A4] Mohammed Ansar Aboobacker & [A5] Zeenath Kollambady Abdulkareem committed offences punishable under section 12(3) of the Passport Act, 1967.

NOW THEREFORE, Government of Kerala, in exercise of the powers conferred by section 15 of the Passports Act, 1967 read with Government of India Notification No. GSR 662(E), dated 01.12.1979 of the Ministry of External Affairs do hereby, accord sanction to prosecute the accused persons [A1] Muhammad Sabad Moideenkutty Pudiyapura, [A2] Nasira Anebagilu Hameed, [A3] Raihanath Chakkamthodi, [A4] Mohammed Ansar

Aboobacker & [A5] Zeenath Kollambady Abdulkareem for the offences punishable under section 12 (3) of the Passport Act, 1967, in Crime No.484/2018 of Kasaragod Police Station and for taking cognizance of the said offences by a court of competent jurisdiction.
