## **ORDER**

As per letter read as 2nd paper above Additional Principal Chief Conservator of Forest (Admin) & Chief Wildlife Warden submitted a proposal for the procurement of a Rapid Response Vehicle for Medical & Surgical Management with equipment amounting to Rs 1.34 Crore. Member Secretary, KSDMA has proposed the above unit under Rs. 120 Crore of untied funds already approved from SDRF vide Government Order read as 3rd paper above, for activities related to recovery, relief and rehabilitation of Meppadi Landslide affected community.

The State Executive Committee meeting held on 14/03/2025 has agreed to the proposal.
