### ORDER

Government as per Orders read 6<sup>th</sup> & 7<sup>th</sup> papers above accorded Administrative Sanction to implement the Project, "Setting up of a Modern Rice Mill Processing

(MRMP) Unit in Pambadi Block of Kottayam District of Kerala" for an amount of Rs.80 Crore (Rupees Eighty Crore only) with RIDF loan of Rs.76 Crore (Rupees Seventy Six Crore only) and Rs.4 Crore as own fund of the Kerala Paddy Procurement Processing & Marketing Co Operative Society Ltd No.4505 (KAPCOS) Kottayam. Subsequently, as per the Order read 8<sup>th</sup> paper above Technical Sanction was accorded for the first part of the above Project for an amount of Rs.33,41,21,669/-(Rupees Thirty Three Crore Forty One Lakh Twenty One Thousand Six Hundred and Sixty Nine only) . As per the letter read 9<sup>th</sup> paper above, the Registrar of Co Operative Societies has submitted proposal for Mobilisation Advance for an amount of Rs. 15.2 Crore {20% of 76 Crore (TFO)} for the implementation of the Project.

2. Government have examined the matter in detail and are pleased to accord sanction to release an amount of Rs. 6.68 Crore (Rupees Six Crore Sixty Eight lakh only) {(20% of Rs. 33.41 Crore (TS amount))} towards Mobilisation Advance for the Project of 'Setting up of a Modern Rice Mill Processing (MRMP) unit in Pampadi Block of Kottayam District of Kerala' by debiting the expenditure under the H/A "6425-00-108-10- Loans to Co-operatives under NABARD RIDF (PV)".

3. The Registrar of Co-operative Societies shall draw and disburse the amount from the Head of Account concerned, in line with the Circular read 10<sup>th</sup> paper above, during the Financial Year 2025-26 and shall ensure the proper utilisation of fund.
