ORDER

As per the Government Order read above, Administrative Sanction was accorded for an amount of Rs.160 lakhs for the renovation of Pookkulam Tsunami Colony in the Chathannoor constituency of Kollam district .

2) As per the decision in the review meeting chaired by the Hon'ble Minister for Fisheries on 25.01.2024 ,it has been decided to re-cast the original estimate for the renovation of Pookkulam Tsunami Colony. Accordingly, the Director of Fisheries as per the letter read above, furnished the Recast estimate Proposal for the sheet roofing of 16 flats (128 family dwelling units) of the Pookkulam Tsunami Colony in the Chathannoor constituency of Kollam for an amount of Rs.160 lakh and has requested to approve the same.

3) The rate of roofing comes to ₹2470.91/m² (₹229.56/ft²). The structural components proposed with 80mm GI post in 4.8mm thickness & other truss work components in 2.6mm thickness. Roofing is proposed with GI profile sheets.

4) Since the Administrative Sanction amount as per the Government orders read above and the amount as per Recast Estimate are same, Government are pleased to accord sanction for the approval of the Recast Estimate proposal of the sheet roofing of 16 flats (128 family dwelling units) of Pookkulam Tsunami Colony for an amount of Rs.160 Lakhs subject to the following conditions.

a)The TS authority shall not allow further deviation in the quantities proposed.

b)The TS authority shall ensure that, the quantities for GI roofing are based on detailed structural design considering economy.
