#### ORDER

The Director of Industries &Commerce, Thiruvananthapuram, as per the letter read as the 1<sup>st</sup> paper above, forwarded a project proposal from the Kerala State Palmyrah Development and Workers' Welfare Corporation Ltd. (KELPALM) for setting up a Palmyrah Product Processing Unit at Kottamam under the scheme 'Assistance to Apex Organizations in the Handicrafts Sector' for an amount of ₹12.5 Lakh from the current year's (2025–26) budget provision under the Head of Account 4851-00-104- 99-P, seeking administrative sanction. The details are as follows:

An amount of ₹50.00 Lakh is provided for the scheme in the 2025–26 budget under the Head of Account 4851-00-104-99-P, for extending capital assistance for technology upgradation, modernization, renovation, and other capital-intensive activities of SURABHI, HDCK, KELPAM, and KADCO. This also includes provisions for the

renovation of selected outlets.

3. The proposed project aims to install machinery at the Kottamam unit of KELPALM for packing products for sale. The financial outlay of this project is ₹12.5 Lakh. The financial outlay of this project proposal is detailed below:

In pursuance of the above, the Government have examined the matter in detail and are pleased to accord administrative sanction for setting up the Palmyrah Product Processing Unit at the Kottamam unit of KELPALM under the scheme "Assistance to Apex Oranizations in Handicrafts Sector" for the year 2025-26 for an amount of ₹12.5 Lakh (Rupees Twelve Lakh and Fifty Thousand only), from the Plan Fund, limiting the expenditure to the current year's (2025–26) budget provision under the Head of Account 4851-00-104-99-P.
