The Chief Engineer, Kerala State Transport Project(KSTP), vide letters read above, informed that KSTP Phase- II - Upgrading Punalur-Ponkunnam Road (SH 8) Package 8 B km 29+840 (Konni) to km 60+000(Placherry) work has been completed on 10.08.2022 and under 5 year maintenance period and forwarded proposal of following additional works in this reach.

- 1. Road safety works- ₹20,83,613/-
- 2. Installation of Traffic Signal Light in Konni Mamuk Junction-₹14,32,450/-
- 3. Construction of concrete retaining wall at Elakollur Ch 33+000 LHS-₹41,53,000/-
- 2. Government have examined the matter in detail and are pleased to accord administrative sanction for Road Safety arrangements and for the installation of Traffic Signal Light in Konni Mamukku Junction amounting to ₹20,83,613 and ₹14,32,450/- respectively as part of KSTP Phase- II Upgrading Punalur- Ponkunnam Road (SH 8) Package

- 4. The traffic signal system should be scientifically designed considering the existing traffic conditions (for Installation of Traffic Signal Light).
