## <u>ORDER</u>

The Ministry of Rural Development (MoRD), GoI, vide letters read as 1st and 2nd papers above, had released an amount of ₹12474 lakh and ₹7584 lakh including pending liabilities of 2024-25, as 1st installment of the 1st tranche of Central Assistance of Material component and Administrative component for the year 2025-26 for the implementation of the MGNREGS in the State. The Mission Director, MGNREGS, vide letter read as  $3^{rd}$  paper above, has submitted proposal for the release of the Central Assistance along with its matching State share.

2. Government have examined the matter and are pleased to accord sanction to release a total amount of ₹242,16,00,000/- (Rupees Two

hundred and forty two crore sixteen lakh only) including pending liabilities of 2024-25 as 1st installment of the 1st tranche of Central share (CS) and its matching State share (SS) towards Material component and Administrative component for the year 2025-26 for the implementation of the MGNREGS in the State from the current budget provision as shown below;
