As per the letter read as 2nd paper above, the State Mission Director, National Health Mission has forwarded a proposal for reallocating an amount of Rs.12,06,91,928/- (Rupees Twelve Crores Six Lakh Ninety One Thousand Nine Hundred and Twenty Eight only) which was resumed from the PSTSB Account No. 799012700000131 with District Treasury, Thiruvananthapuram in respect of National Health Mission.

2) As per the G.O read as 3rd paper above, an amount of ₹3,69,31,893/- and ₹4,87,19,159/- have been additionally authorised under the Head of Accounts "2210-01-110-10-PV" and "2210-03-103-90-PV" respectively.
