ORDER

The budget provision for the Pradhan Mantri Jan Arogya Yojana (PMJAY)/Karunya Arogya Suraksha Padhathi (KASP) for the financial year 2026-27 is ₹900 crore, of which ₹768 crore is provided under the State Plan under the Head of Account 2210-06-800-81(P)State Scheme , and ₹132 crore is provided under the Centrally Sponsored Scheme (CSS) under the Head of Account 2210-06-800-80 (2) State Share

2) As per the GO read as 2nd paper above, sanction was accorded for the release of ₹199.10 crore under the Head of Account 2210-06-800-81 – PMJAY-KASP – State Scheme (P) (V). Subsequently, as per the GO read as 4th paper above, sanction was also accorded for the release of ₹100.90 crore under the Head of Account 2210-06-800-80(2) – PMJAY/KASP – State Share.

3) It has been reported that, as on 30.06.2026, payments in respect of 11,73,659 cases under AB-PMJAY/KASP, Arogyakiranam and Karunya Benevolent Fund (KBF), involving an amount of ₹19,20,86,04,372/- are pending for disbursement.

4) Government have examined the matter in detail. In view of the immediate financial liabilities under the above schemes, Government are pleased to accord sanction for the release of an amount of ₹200 crore

(Rupees Two Hundred Crore only) under the Head of Account 2210-06-800-81 (P)(V) through IBDS, as an interim measure, for meeting the immediate liabilities under the AB-PMJAY/KASP and Arogyakiranam schemes.
