ORDER

In the Budget Estimates for 2025-26, an amount of Rs.27.60 crore was provided to e Health Kerala / SDHM under the Head of Account 2210-01-001-88(P). From this provision, based on the Administrative Sanctions, Government have released a total amount of Rs.18,46,29,762/- to the PSTSB account of e Health Kerala for the implementation of the plan scheme "Kerala Digital Health Mission- e Health Programme", during the financial year 2025-26, as detailed below:

The Project Director, e Health Kerala, as per the letter read as 1st paper above, has informed that at the end of the financial year 2025-26, the unspent balance available in the PSTSB account of e Health Kerala amounting to Rs.6,11,73,508/- was resumed by Government. The Project Director has also informed that the works under the sanctioned components (fund releases already sanctioned vide G.O.(Rt)No.2068/2025/H&FWD dated 26.07.2025, G.O.(Rt)No.3699/2025/H&FWD dated 27.11.2025 and G.O.(Rt)No.3993/2025/H&FWD dated 27.12.2025), have already been completed, and the corresponding payments are pending for settlement as detailed below :

Since these committed liabilities require urgent clearance, the Project Director has requested to re-allocate the aforementioned amount of Rs.4,23,48,015/-, out of the funds resumed during the FY 2025-26, to the PSTSB Account No.799012700000936 of e Health Kerala, from the budget provision of Rs.21 crore allocated for the financial year 2026-27.
