ORDER

The Staff Pattern and Promotion Policy for the employees of Kerala Tourism Development Corporation Ltd (KTDC) was approved by the Government as per the order read as 1st paper above w.e.f 22.06.2010. Subsequently, as per the order read as 2nd paper above, the Government had approved the Recruitment (Qualification &

Method of Appointment) Regulations of Kerala Tourism Development Corporation Ltd 2014 subject to certain modifications.

2. The Secretary, Kerala Public Service Commission as per his letter read as 3rd paper above has recommended to amend the Special Rules of KTDC by amending the Qualifications of posts of Boat Lascar and Driver. Accordingly, the Managing Director, KTDC as per letters read as 5th & 6th papers above has submitted an amended proposal to the Recruitment (Qualification & Method of Appointment) Regulations of KTDC Ltd. 2014 with regard to the posts of Boat Lascar and Driver.

3. Subsequently, as per the letter read as 7th paper above, the Secretary, Kerala Public Service Commission has advised the Government that there is no need to amend the current qualification criteria for the post of Boat Lascar, as the qualification "Valid Certificate of Competency as Boat Lascar with 3 years standing endorsement" has already been included in the existing recruitment rules. Additionally, the seven qualifications prescribed in Clause 37 of the Kerala Inland Vessel Rules, 2010, for obtaining the Lascar License have also been incorporated into the qualifications for the post as per the current recruitment rules.

4. In the above circumstances, Government have examined the matter in detail and are pleased to amend the Recruitment (Qualification & Method of Appointment) Regulations of Kerala Tourism Development Corporation Ltd, 2014 with respect to the name and qualification in the Wing XII (2) as stated below:-

Medical fitness shall be proved by a proper Medical Certificate obtained from a Medical Officer not below the rank of an Assistant Surgeon.</p> <p>4. Physically Handicapped persons are not eligible to apply for the post."</p>
