## **ORDER**

As per Government Order read as paper 1<sup>st</sup> above, Administrative Sanction was accorded for the Construction of 200 Bedded Cardiology Block at Government Medical College, Kottayam for an amount of Rs.36,41,84,000/- with NABARD loan assistance (under NABARD RIDF Tranche XXVI [2020-21] project) of Rs.30,95,56,000/-. Subsequently, M/s HITES was entrusted as the PMC for the work, as per Government Order read as paper 2<sup>nd</sup> above. Recently, vide Government Order read as paper 3<sup>rd</sup> above, Technical Sanction was accorded for the Revised Estimate / Deviation Statement of the works related to 200 bedded Cardiology Block at Government Medical College, Kottayam, for an amount of Rs.26,22,95,113/- (Excluding GST).

2. As per the letter read as paper 4<sup>th</sup> above, the Director of Medical

Education (DME) informed that as reported by Technical Committee for DME works, the PMC M/s HITES had submitted a Revised estimate (RE 2) for the civil works pertaining to the Construction of 200 Bedded Cardiology Block at Government Medical College, Kottayam, with a net savings of Rs.75,00,26/- on 19/05/2025. The DME pointed out that since the NABARD RIDF Tranche 26 is going to end on 31.12.2025, the final Project Completion Certificate of the Construction of 200 bedded cardiology block has to be communicated to NABARD before 31.12.2025 to avail the final installment of the project. DME has further more indicated that pending amount has to be claimed from NABARD for this project and hence approval of the current Revised Estimate is essential for preparing the final bill for the civil works and hence for the project completion. In view of the above, DME requested to approve the revised Estimate no.2 (RE 2) of the works related to the Construction of 200 Bedded Cardiology Block of Government Medical College Kottayam amounting to Rs.25,80,32,790/- and to issue orders accordingly at the earliest.
