ORDER

As per the letter read above, the Chief Engineer, Harbour Engineering Department has submitted the proposal 'Construction of Cheekkanthuruth - Puthenthuruth walkway ' in the Chavara constituency of Kollam district for a total outlay of Rs.85 lakh, from the H/A 4405-00-104-31-00-34-03-P-V, included in the Budget Estimate 2025-26 Appendix II (SI. No.22, Budget No.2679).

2) Government have examined the matter in detail and are pleased to accord sanction for the work 'Construction of Cheekkanthuruth - Puthenthuruth walkway ' for an amount of Rs.85 lakhs, subject to the following conditions:

1) TS authority shall ensure the structural adequacy and structural stability of the existing bridge structure constructed in first phase of the project before issuing the Technical Sanction.

2) The total thickness of the CC approach road provided as 25 cm appears to be on the higher side. Hence, the TS authority shall review and adopt the thickness based on a pavement design appropriate to the expected traffic volume.

3) Lump sum quantity is provided for reinforcement items in RCC work. Hence, quantity shall be arrived based on the design drawings before according TS.

4) The TS authority shall ensure that the design of retaining walls in the approach road is carried out in compliance with the directions issued in the prevailing CTE circulars.

5) The correctness of the rates adopted for the observed data included in the estimate if

any, shall be ensured by the TS authority.

6) The competent authority shall ensure the admissibility of provisions included in the estimate with the site conditions before issuing the Technical Sanction.
