### ORDER

2. The following are the qualifications and age limit prescribed by the Governing Body meeting of RCC Society held on 23.6.1998 and as amended in the Governing body meeting held on 06.1.2009.

- a) The person should be a Medical Doctor possessing Post Graduate Medical Qualification.
- b) He/she should have international standing as evidenced by long professional experience of not less than 20 years in academic and research activities in Oncology related areas.
- c) Proven ability in conceptualisation and implementation of major research projects clinical and hospital projects with extra mural funding.
- d) Research publications in peer reviewed Oncology and medical journals.
- e) Proven organizational ability as evidenced by establishment of institutions, departments and their administration.
- f) Age at the time of appointment shall be less than 58 years.
- g) The tenure of appointment shall be 3 years extendable to 5 years.

3. The following are also ordered:

- a) Search Committee will advertise the above post in all leading dailies and websites and circulate a note to Indian Council for Medical Research and other professional bodies.
- b) The recommendations of the Search Committee will be submitted directly to the Government for consideration and final selection.
- c) The Selection Committee will complete the selection process within three months time from the date of this order.
- d) The Director,MCC, Convener of the Search Committee shall follow up and co-ordinate the selection process to ensure time bound completion.
