ORDER

The Chief Engineer (Roads) as per the letter read as 1st paper above has submitted detailed estimate in respect of the work “Budget 2023-24 (20% Budget provision): Upgradation (1.500 km) with BM & BC to Chunkam Mankadavu Kottammal road in Kondotty LAC in Malappuram District" , at a total estimate cost of Rs.150 Lakh and requested government to accord Administrative Sanction for the work

2. Government have examined the matter in detail and are pleased to accord Administrative Sanction for work “Budget 2023-24 (20% Budget provision): Upgradation (1.500 km) with BM & BC to Chunkam Mankadavu Kottammal road in Kondotty LAC in Malappuram District" for an amount of Rs. 150 Lakh (Rupees One Crore Fifty Lakh only) by debiting the expenditure from the Head of Account 5054-04-337-97 -ODR subject to the following conditions;

1. TS authority shall ensure the admissibility of provisions included in the estimate with the site conditions before issuing Technical Sanction.
2. The Chief Engineer shall ensure that the works proposed in the estimate shall satisfy the functional requirements as envisaged.
3. The TS authority shall review the difference in proposed

foundation length (200m) against the super structure length (300m) before issuing Technical Sanction.

4. The Structural provisions given for the drain shall be ensured by the TS authority before according TS and shall meet the requirements as per IRC.

5. The working chainages shall be ensured by the TS authority.
