ORDER

Sri. V. Maniyan Part Time Sweeper, Perunkadavila Grama Panchayat, Thiruvananthapuram has been working as a market sweeper in the Marayamuttam Public market since 01.03.2001. His request for regularization in the Part Time Sweeper post was rejected vide Government Orders read as 2nd and 4th above on the ground that he is a daily waged employee recruited as market sweeper and those market sweepers are not entitled to the benefit under the provisions of Government Order read as 1st above.

2. Aggrieved by denial of regularisation in service the applicant had filed WP(C)No 3866/2011 before the Hon'ble High Court. The Hon'ble High Court has disposed of the writ petition by directing the Panchayat to submit a proposal for regularization of the petitioner before the Government in accordance with the Exbt P4 guidelines and the Government to issue an order in accordance with the Exbt P4 guidelines on the basis of Ext.P2 sweeping area certificate. . In compliance to Judgment read as 6th paper above, the Principal Director had furnished the proposal for regularization of the petitioner vide read as 7th paper above.

3. The guidelines regarding the determination of the sweeping area of Govt. offices specified in the appendix of Government Order read as 1st paper above and as per para (vii) of Government Order read as 3rd paper above wherein areas of bus stands, streets, markets, public gardens etc. are excluded in determining the sweeping area . Hence the sweeping area in Government Offices alone are covered in the guidelines in the Govt. order which further provides for regularisation of service. Hon. Court had observed in the judgment that the classification of casual sweepers based on the place of work for the purpose of regularisation when they fulfill all other conditions of regularisation does not have any intelligible difference having nexus with the object to be achieved and directed to consider the proposal of regularisation of the petitioner in the timelimit granted.

4. Government have examined the matter in detail in the light of the judgment read as 6th paper above and are pleased to accord sanction to regularise the service of Sri. V. Manian, Casual Sweeper, Marayamuttam Public Market, Perunkadavila Grama Panchayat. The date of effect of regularisation in the post of Part Time Sweeper is the date of issuance of this order in view of the instructions contained in the G O read as 5th paper above.

5. The Judgment of the Hon'ble High Court of Kerala read as 6th paper above is complied with accordingly.
