ORDER

The Chief Engineer, Public Works(Roads), as per his letter read as 1st Paper above, has requested to accord Administrative Sanction for the work "Improvements and providing BM & BC to Udayagiri - Arivilanja Poyil - Josgiri Road Km 0/000 to 6/300 for an amount of ₹ 1000 Lakh under the head of account 5054-04-337-99-MDR.

2) Government have examined the matter in detail and are pleased to accord Administration sanction for the work "Improvements and providing BM & BC to Udayagiri - Arivilanja Poyil - Josgiri Road Km 0/000 to 6/300 for an amount of ₹ 1000 Lakh (Rupees Ten Crore Only) under the head of account 5054-04-337-99 subject to the following conditions;

1) The scarified or dismantled pavement layers shall be re-used below the GSB layer as sub base or at shoulders with proper compaction. The thickness of GSB layer in the carriageway shall be

reduced accordingly.

2) The thickness of existing pavement crust shall be taken into account while proposing the total pavement thickness . The thickness of fresh GSB&WMM, if any required, shall be optimized to the normal provisions

3) The provision for shoulder concrete, berm concrete, Irish drain, etc shall be allowed as shoulder protection in essential stretches like gradients and curves only and for a minimum width of 50 CM only

4) The proposals for RCC cover slabs for drains, Foot Paths with Paver blocks or Tiles, GI Pipe hand rails, etc. shall be allowed in technically justified locations only.

5) The CC Side protection walls shall be substituted with DRM and RCC belt as stipulated in Govt. Circular No.64/2021/Fin dated 05/08/2021

6) Proper account of re-usable / serviceable materials obtained from dismantling items of work shall be ensured

7) The provisions for Road furniture shall be regulated as per IRC guidelines after assessment of existing items available at site. Proper account (Register) shall be maintained for the road furniture items.

8)The provisions for construction of culverts shall be regulated as per IRC guidelines

9) Defect liability period/Running Contract of the proposed road reach shall be ensured. Also, duplication of proposals under different schemes for the same reach shall be avoided.

10) The Correctness of the rates adopted for observed data's included in the estimates shall be ensured by the TS authority

11) In cases where dismantling of existing DR masonry structures is necessitated as per site conditions, its chainage shall be clearly specified in the M-Book and the rubble so obtained shall be reused

properly and accounted as departmental rubble.
