Government have constituted State Forest Development Agency by designating Principal Chief Conservator of Forests as Chairman and Chief Conservator of Forests (E&TW) as the Member Secretary as per Government Order read as 1<sup>st</sup> paper above. Later, as per G.O read as 2<sup>nd</sup> paper above, Principal Chief Conservator of Forests (Dev&PFM) and Additional Principal Chief Conservator of Forests (E&TW) were designated as the Chairman and Member Secretary respectively. Principal Chief Conservator of Forests & Head of Forest Forces, vide letter read 5<sup>th</sup> above, reported that the above ex-cadre posts have been discontinued and requested to designate the Principal Chief Conservator of Forests (P&D) as the Chairman and the Chief Conservator of Forests (E&TW) as the Member Secretary since Principal Chief Conservator of Forests (P&D) supervises the works of Chief Conservator of Forests (E&TW).

Government have examined the matter in detail and are pleased to reconstitute the existing organizational set up of State Forest Development Agency, Kerala by designating the Principal Chief Conservator of Forests (P&D) as the Chairman and the Chief Conservator of Forests (E&TW) as the Member Secretary of State Forest Development Agency, Kerala.
