### **ORDER**

An amount of Rs.30.90 crore was provided under the Head of Account 2215-01-102-80-P (V) for the implementation of the Project 'Sustainability Support to Community Managed Water Supply Schemes for the year 2024-25. As per Government Order read as 1<sup>st</sup> paper above, the estimated cost for the proposed programme is reduced to Rs.1421.40 lakh. As per the Government Orders read as 2<sup>nd</sup>, 3<sup>rd</sup> and 4<sup>th</sup> paper above, an amount of Rs.290 Lakhs was sanctioned and released as a part of revised allocation.

2. Subsequently, as per the Government Order read as 5<sup>th</sup> paper above, the Administrative Sanction was accorded for the reduced amount of Rs.1131.40 lakh without effecting Rs.290 lakh already sanctioned and released during the year before issuing the AS. Hence as per the Government Order read as 6<sup>th</sup> paper above, revised Administrative Sanction was accorded for a total amount of Rs. 1421.40 lakh for the implementation of the project 'Sustainability Support to

Community Managed Water Supply Schemes'. As per Government Order read as 7<sup>th</sup> paper above, an amount of Rs.112.67 lakh was sanctioned and released for the implementation of the scheme.

- 3. As per the letter read as 8<sup>th</sup> paper above, the Executive Director, Jalanidhi has informed that an amount of Rs.2,90,00,513 is urgently required for the implementation of activities during the current financial year and for the settlement of pending bills for the works completed during previous years. As the works related to the rehabilitation of water supply schemes have been initiated and the works activities are to be carried out and the bills are to be settled before the closure of the financial year, the ED has requested to release the same amount from the budget provision for the financial year 2024-25.
- 4. Government have examined the matter in detail and are pleased to release an amount of Rs.290 lakh under the Head of Account 2215-01-102-80-P(V) for the implementation of the scheme 'Sustainability Support to Community Managed Water Supply Schemes' subject to the following terms and conditions of fund release.
  - i. The amount released shall be transfer credited to PSTSB account in compliance of GO (P) 62/2018/Fin dated 16/4/2018.
  - ii. The instructions in Circular No.84/2008/fin dated 09/12/08, Circular No.8/2018/Fin dated 30/01/2018 & G.O(Ms)No.93/2020/Fin dated 11.09.2020 shall be scrupulously followed.
- iii. The Executive Director, Jalanidhi shall furnish duly authenticated detailed component wise statement of expenditure and Utilization Certificate as per instructions in GO.(Ms)No.4/2020/Fin dated 09/01/2020.
- iv. If there is un-utilized amount at the end of this financial year that should be refunded to the Government during the financial year itself.
